All vendors <u>MUST</u> submit an application by August 1st to be guaranteed a space. Applications can be mailed or emailed to <u>eriecountyfairvendors@hotmail.com</u>. Please stop at <u>Heritage Hall</u> located at the north end of the fairgrounds upon arrival prior to set up. At this time your vending placement will be given at this time and your payment for the week must be paid in full prior to the beginning of the fair.

- <u>ALL FOOD VENDORS MUST</u> have <u>ONE MILLION DOLLARS</u> worth of liability insurance. Please email certificate of Insurance with application.
- Concessions must be set up by 4:00pm on Monday, August 26th. Tear down must be after 10pm Saturday August 31st.
- Vendor Weekly Buttons, 2 will be given with the contract, and any additional buttons can be purchased upon arrival at a discounted price. Each person working during the shift will need to have a fair button.
- Concession must be always kept clean and presentable, and trash must be put in proper containers.
- Do not put large cardboard boxes in trash cans; set them beside the trashcans at the end of the evening.
- All cooking oil must be disposed of in containers and placed next to the garbage cans prior to 8am the next day.
- All stands <u>MUST</u> be open during fair hours. Monday-Thursday 4-10pm, Friday 4-11pm, and Saturday 11-10pm.
- Service gate is closed at 4:00 PM and all vehicles must be parked in the parking lot.
- No vehicles can be parked next to your vending area.
- Outside space vendors MUST buy a minimum of ten (10) foot space. Vendors can set up all day Sunday, August 25, 2024, or during the morning on Monday, August 26, 2024, prior to 3pm.
